

The SJC Institution's Innovation Council (SJC-IIC) & Department of Business Administration (CA), St.Joseph's College of Arts & Science (Autonomous), Cuddalore organized an Expert Talk on **"Process of Innovation Development, Technology Readiness Level (TRL), Commercialisation of Lab Technologies & Tech-Transfer"** on 28.02.2023 (Tuesday) for the Shift I & II BBA(CA) students in online mode. The Resource Persons for the programme were Mr.Rajkumar Thangavel, Senior IT Architect, Chennai. Mr. R. Karthikeyan, Project Head, Photon Interactive, Chennai. The programme was presided over by Rev.Fr.G.Peter Rajendiram, Secretary, felicitated by Rev.Fr.Dr.A.Alex, Head, Department of BBA(CA) and Dean of Studies. The programme was coordinated by Mr.M.Om Prakash, Assistant Professor of BBA(CA). **100 students** participated in the programme.

#### **Objective of the programme:**

- To understand about the Process of Innovation, Technology Readiness Level (TRL).
- To learn how to commercialize lab technologies.
- To know about transfer of technology.

#### Process of Innovation Development & Technology Readiness Level (TRL):

The resource person started the session with day to day challenges which deliberately needed a solution. Every solution will arise through creativity which eventually lead to a sustainable innovate products/services. He then explained about the innovation funnel where every innovation is an outcome of every possible trial and error which happens in a controlled environment.(performed in specific kind of laboratories and research centres). He briefly explained about various levels of Technology Readiness Level from TRL -1 to TRL - 5. He also emphasized the difference between each TRL.He explained the role of Technology parks, incubation centres, research parks, R&D centres in enhancing and supporting the development of Innovation.

#### Commercialization of Lab Technologies & Technology Transfer:

The next session discussed about Commercialization of Lab Technologies & Technology Transfer. The resource person emphasized that the best innovative solutions developed in the laboratory will flow through a sequence of process before massive production and reaches the market place **(L2M) process**. He also stated that without commercialization, the innovative solutions remain useless and does not serve any purpose to the world community. Many of the innovations originate in different parts of the world but it shall be commercially viable through the process of Technology Transfer. Technology transfer enable the innovative solutions to cross boundaries of various countries and enter the best market places in the world. He also gave the examples of Mobile technology, 5G evolution, green energy and also quoted that India has the best technology in space sector developing most competitive satellites and transfer the technology to other countries.

#### **Outcomes of the programme:**

The students understood about Process of Innovation and Technology Readiness Level (TRL). The students learn how to commercialize lab technologies and the process of technology transfer, need, significance and impact of technology transfer.
