LEGAL AWARENESS CAMPAIGN




What Constitutes Ragging

- Any disorderly conduct of spoken words or written languages or any act which has the effect of testing or handling any other student with rudeness.
- Indulging in rowdism or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student.
- Asking the students to do any act or to perform something which such student will not / in the ordinary course do and which has the effect causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to any individual or a group of students.
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health of the person.
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without intention to derive a sadistic pleasure or showing off power or authority by a student over any fresher or any other students.

Punishable Ingredients of Ragging:

- Abetment and criminal conspiracy to ragging.
- Unlawful assembly and rioting while ragging.
- Violation of decency and morals through ragging.
- Injury to body, causing hurt or grievous hurt.
- Wrongful restraint and confinement.
- Assault as well as sexual offences or even unnatural offences.
- Extortion.
